

APPLICATIONS

Methyl Polyethyleneglycol Methacrylate 2000 (MPEGMA 2000) forms homopolymers and copolymers. Copolymers of Methyl Polyethyleneglycol Methacrylate 2000 (MPEGMA 2000) can be prepared with (meth)acrylic acid and its salts, amides and esters, and with methacrylates, acrylonitrile, maleic acid esters, vinyl acetate, vinyl chloride, vinylidene chloride, styrene, butadiene, unsaturated polyesters and drying oils, etc.

Methyl Polyethyleneglycol Methacrylate 2000 (MPEGMA 2000) is also a very useful feedstock for chemical syntheses, because it readily undergoes addition reactions with a wide variety of organic and inorganic compounds.

FEATURES AND BENEFITS

Methyl Polyethyleneglycol Methacrylate 2000 (MPEGMA 2000) can be used to impart the following properties to polymers:

STORAGE & HANDLING

Inorder to prevent polymerization Methyl Polyethyleneglycol Methacrylate 2000 (MPEGMA 2000) must always be stored under air, and never under inert gases. The presence of oxygen is required for the stabilizer to function effectively.

Freezing of Methyl Polyethyleneglycol Methacrylate 2000 (MPEGMA 2000) results in segregation of monomer and inhibitor. In addition it is especially important to replenish dissolved oxygen after melting the drummed material prior to use. Replenishment dissolved oxygen and mixing of MEHQ into the monomer can be done using a palette shaker or a drum tumbler.

The melting process requires temperatures of 20 °C or higher but at a maximum of 35 °C as the heating temperature. Warming the product in a room of 20...25 °C over several days is the preffered option. As an alternative if faster melting is required heating cabinets using hot water or hot oil are the preferred apparatus for the thawing process of Methyl Polyethyleneglycol Methacrylate 2000 (MPEGMA 2000) since this avoids hot spots. Local hot spots of more than 35 °C may result in premature aging of material. Product temperatures of more than 45 °C may result in a polymerization of the monomer.

During storage as a molten liquid it is advisable to replenish the dissolved oxygen content on a weekly basis. Methyl Polyethyleneglycol Methacrylate 2000 (MPEGMA 2000) has to contain a stabilizer and the storage temperature must not exceed 20 °C to prevent premature quality degradation. If the above mentioned conditions are met a storage stability Methyl Polyethyleneglycol Methacrylate 2000 (MPEGMA 2000) of 6 months can be expected upon delivery.

SAFETY
